

**AREA CLOSURE for PUBLIC SAFETY**

**OKANOGAN-WENATCHEE NATIONAL FOREST**

Pursuant to 36 CFR 261.50(a) and (b), the following acts are prohibited on the Okanogan-Wenatchee National Forest:

1. **To go into or be upon any area closed for protection of public health or safety.** For the purposes of this order, it is prohibited to enter or be within National Forest System lands, roads, or trails within the area of the Wenatchee River Ranger District closure area consisting of:

The southern boundary of the fire area closure begins on Hwy 2 at the intersection of sections 10 and 11 in T.24N R. 17E. The boundary follows the Forest Boundary south to the junction with Icicle Road and continues on Icicle Road to the Chatter Creek Trailhead. All trails and areas North of Icicle Road are closed to public entry including Icicle Ridge Trail (#1570), Fourth of July Trail (#1579) and Chattercreek Trail (#1580). Where Chattercreek trail (#1580) and Icicle Ridge Trail (#1570) intersect, the closure boundary continues north and west along the Icicle Ridge Trail (#1570) to Ladies Pass. All areas and trails North of Icicle Ridge Trail are closed to entry including Icicle Ridge Trail (#1570), the Hatchery Creek Trail (#1577), Painter Creek Trail (#1575), Index Creek Trail (#1572), and the South Fork Chiwakum Trail (#1571). The Western Boundary of the fire closure begins at the South Fork Chiwakum Trail (#1571)/Icicle Ridge (#1570) junction and continues north to Snowgrass Mountain and follows the Chiwakum Mountain Range North/Northeast to the intersection of Highway 2 and FS 6940 at Township 26N, Range 16 E, Section 3. The closure includes trails and areas south and west of Highway 2 between FS Rd. 6940 and township 25N R17 E, Section 33 including Lake Ethel Trail (#1585), Roaring Creek Trail (#1584), Lock Eileen (#1584.1), North Fork Chiwakum Trail (#1591), McCue Ridge Trail (#1574), and Glacier Creek Trail (#1573).

This closure is effective as of **July 24, 2014** and will remain in effect until terminated.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission, including Washington State employees in performance of an official duty, and their authorized contractors.
2. Any Federal, State or local officer, or a member of any organized search and rescue, emergency services, or firefighting force in the performance of an official duty.
3. Any private land owner exercising an existing right to access their own private property which is otherwise within the closure area as described above.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.
