CALL FOR BIDS**

Sealed bids will be received by the City of Leavenworth, Washington, at the reception desk located at 700 U.S. Highway 2, Leavenworth Washington, until 2:00 p.m., March 25, 2016. Bids will then be opened and publicly read at 2:05 p.m. on that same day at City Hall, 700 U.S. Highway 2, Leavenworth, Washington 98826, for:

**Chumstick Highway Lift Station  
Pumps and Auxiliary Generator**

Note: The Proposed Subcontractors list must be submitted with the bid package within the deadline listed above, and will NOT be accepted after that deadline.

The Work to be performed within 20 working days from the date of Notice to Proceed consists of furnishing all materials, equipment, tools, labor, and other work or items incidental thereto for:

- 1) Installation of two 3 horsepower submersible wastewater pumps in a wet well structure constructed by others,
- 2) Installation of an auxiliary generator, automatic transfer switch, and concrete slab,
- 3) Installation of conductors in conduit installed by others,
- 4) Installation of power and control panels, instrumentation, and concrete slabs,
- 5) Installation of appurtenant valves in a vault structure constructed by others.

The Work will be coordinated with the Chumstick Trail and Water/Sewer Extension contract. The Notice to Proceed will be issued when the wet well and vault structures are complete.

All bid proposals shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the total amount of such bid proposal, including sales tax. Should the successful bidder fail to enter into such contract and furnish satisfactory payment and performance bonds within the time stated in the Contract Documents, the bid proposal deposit shall be forfeited to the City of Leavenworth.

The work on this project shall be accomplished in accordance with the *Standard Specifications for Road, Bridge, and Municipal Construction*, 2016 edition, as issued by the Washington State Department of Transportation (WSDOT) and the American Public Works Association (APWA), Washington State Chapter (hereafter "Standard Specifications"). The Standard Specifications, as modified or supplemented by the Amendments to the Standard Specifications and these Special Provisions, all of which are made a part of the Contract Documents, shall govern all of the Work.

The City of Leavenworth in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-Assisted Programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises as defined at 49 CFR Part 26 will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin, or sex in consideration for an award.

This Invitation to Bid may be canceled at the discretion of the City. If the invitation is canceled, notice of cancellation will be sent to all parties who have registered on the Planholders list at Builders Exchange. The notice will briefly state the reason for cancellation.

The City reserves the right to reject any and all bids, to waive any informality in the bidding, and to make the award to the lowest responsible bidder as determined by the City.
