#### SUPPLEMENTAL COUNCIL AGENDA

#### 1. Discussion: Leavenworth Lodging Tax Programs Review Process

This time is for the City Council to consider any final suggested changes to the new application forms and criteria for the Festivals/Events and Tourism Hospitality/Special Project Grant programs. The Council discussed these new materials at the City Council Annual Retreat held in April and since then, the Economic Development Committee has been meeting each month to review the documents, and is now presenting the full Council with the final documents for the 2020 program. If no additional changes are necessary, staff anticipates publication of the program at the end of October and again in November with an application deadline of December 31, 2019. The Council will need to determine who and how the applications will be scored by early January, as the approvals are anticipated to be made by February 11, 2020. If the Council would like to amend these deadlines, staff will need direction on those dates prior to opening them up to the public this month.

Once the final review is considered by the City Council, the City Council will be asked to authorize the funding of each program. The Economic Development Committee is recommending that the Festival/Event program be funded at \$15,000 for the 2020 program year and that the Tourism/Special Project program be funded at \$35,000 for the 2020 program year. Both programs would be funded with Lodging Tax funds. The Festival/Event program would limit grant requests to \$3,000 and the Tourism/Special Project program would limit grant requests to \$7,500.

# 2. <u>Council Support for Chelan County LTAC (Lodging Tax Advisory Committee)</u> Applications

The City Council is being asked to review and consider approval of a letter of support for ongoing maintenance and operation of the requested capital improvements. This year, the City is considering making three (3) applications for capital funding. The projects would be for cost sharing for the resurfacing of the Festhalle Main Floor, the purchase of mobile reader boards to direct traffic, and for the lighting installation at the recently purchased DOT property. One of the requirements for the grant application is for the legislative body to provide a letter of support that if the requests for the capital improvements is funded by the Chelan County Lodging Tax Advisory Committee the municipality will assume the ongoing maintenance and operational costs. The City already assumes the cost for maintenance and operation of the Festhalle and DOT Parking Lot. The new reader board signs would be an added piece of equipment that would be included on the Equipment Repair and Replacement schedule. At this time, the use and operation of the reader boards would be only under City or County operational control.

## 3. Request for Proposal – Authorization to Proceed for On-street Parking Meters

The City Council is being asked to review and consider authorization of the posting and advertising of a Request for Proposal (RFP) for a firm to provide Parking Equipment and Management Services. The selected firm will provide the City with management processing, collection services, permit management, parking citation issuance, and the purchase of metering equipment to implement an on-street paid parking program in the downtown commercial area. This request for authorization is being recommended by the Parking Advisory Committee (PAC). The Parking Advisory Committee presented their recommendations to the City Council at the September City Council Study Session. Since that time, the recommendations have been presented to the Downtown Steering Committee, Residential Advisory Committee, and Leavenworth Area Chamber of Commerce Board. This step will allow the PAC to select a parking consultant that will assist in the implementation of the recommendations. The PAC will review and evaluate the

submittals and provide a recommendation to the City Council for approval. If a firm is approved to work with the City, one of the first steps will be to develop steps for continuing the public outreach and education prior to the on-street parking program being implemented.

Submittals to the RFP require information on the firms past experience implementing a procurement project of similar scope, identifying the on-site point of contact person and providing his or her experience, the ability to provide the requested software and equipment, and the subsequent pricing of the software and equipment, including any ongoing monthly/annual costs.

## 4. Golf Course Property Sales

### a) Bid Acceptance and Property Conveyance

The City Council is being asked to review and consider the approval/acceptance of the two (2) Purchase and Sale Agreements that were submitted by private bid for the purchase of the City owned property referred to as the Golf Course Properties. Both bids were submitted within the required time frame and with completed documentation.

Bid #1 was submitted on August 15, 2019 by Snow Creek, LLC, represented by Mr. Cameron West of Mike West Leavenworth Realty. The bid amount was for \$257,000, a cash offer, with a deposit of \$5,000 earnest money. The selected property was Lot B, 9139 Icicle Road, Leavenworth, WA.

Bid #2 was submitted on August 16, 2019 by Chavase, LLC, represented by Mr. Cameron West of Mike West Leavenworth Realty. The bid amount was for \$257,000, a cash offer, with a deposit of \$5,000 earnest money. The lot selected by this bidder was Lot C, 9125 Icicle Road, Leavenworth, WA.

At this time, the City Council is being asked to accept both bids, proceed with selling the properties, and authorize the Mayor to sign the closing documents. The purchase of properties is expected to occur on or before December 15, 2019. Each sale should be recognized in separate motions.

## b) Resolution 19-2019 Golf Course Property Sales Committment

The City Council is being asked to review and consider approval of Resolution No. 19-2019, which creates a restricted fund balance within the City's General Fund for the use of money's received from the sale of the Golf Course Properties. The restricted use of those funds would be for the future purchase of park land or land for recreational use by the citizens of Leavenworth. The City Council has previously discussed and identified one significant reason for declaring the three Golf Course Lots as surplus and allowing for the sale of those lots; and that was to create available funding to purchase the Osborn School property, if and when, the property becomes available. Resolution No. 19-2019 memorializes that intention of the City Council and protects those funds from being simply absorbed into the City's General Fund without a specific use of the funds being identified. The resolution also provides for some flexibility; in the event that the Osborn site is not available or for other reasons not purchased by the City, the resolution does allow for the purchase of other property for park or recreational use. The resolution also will be useful in working with other potential funders, showing that the City has funds available for the purchase of future park/recreational property.

The resolution is not binding, should the City be in need of spending the funds for other needs, the City Council could rescind Resolution No. 19-2019 by a simple majority.

• MOTION ITEM B: The Leavenworth City Council moves to approve Resolution 19-2019 restricting the funds received for the sale of the Golf Course Properties to be used for the future purchase of additional park land or recreational land use.

## 5. Special Use Permit Noise – Timbrrr! Winter Music Festival

The City Council is being asked to consider approval of a Special Use Permit (SUP) to allow an extended time period and increased noise levels for the Timbrrr! Winter Music Festival. This will be the seventh year that the Timbrrr! Partners held this annual Winter Music Festival in the City of Leavenworth. The event is scheduled to take place at the Leavenworth Festhalle on Friday, January 24 and Saturday, January 25, 2020. This is a live music event; music begins each evening at 5:00 PM and ends at 12:30 AM each day. Approval of the Special Use Permit would allow for the permitted dBA noise and sound levels to be permitted to a level not to exceed 95 dBA.

In regard to the SUP, the LMC 9.33.040 Exemptions allow the City Council to approve with conditions or deny special use permits at its sole discretion. To approve the SUP, the Council must consider the conditions and provisions for granting a special use permit stipulated in LMC 9.33.040 (I) (Items 1-5 below). The Council's decision of approval or denial of the SUP must be based on whether the request meets the following criteria, information relating to each:

- 1. The special use permit is necessary: The permit is necessary because the noise level at various times during the event may exceed the 70 dBA or 60 dBA level specified in LMC 9.33. The event is held within the confines of the Festhalle, so the noise generally will be contained within the building.
- 2. There exists a special circumstance relative to size, topography, location, or surroundings of the subject property: The Festhalle facility is located within the Central Commercial District, which is the preferred location for these events to be held.
- 3. Requesting property owner or agency has provided a plan for mitigation of noise to be implemented on the approval of the special use permit: The organizers will be monitoring the noise levels outside the building to ensure that they do not exceed the 95 dBA noise level. Noise monitoring from other events typically shows that sounds levels on the exterior of the Festhalle do not exceed the 70 dBA which is allowed under LMC 9.33.
- **4.** That the granting of the special use permit will not be materially detrimental to the comfort, health, or safety of the public: The granting of the permit is for a 2-day event. Past events held within the confines of the Festhalle facility have not been an issue with surrounding property owners, provided that the doors remain closed during the performance times.
- **5.** That the special use permit is limited to not more than 14 days in any 90 day period: The permit is for a period of 2 days.

Staff is recommending approval of the Special Use Permit, allowing the noise exemption because the event is contained within the Festhalle area and events that have been held within the facility have not had the noise issues associated with events held in outdoor or in tented venues. Additionally, the organizers have volunteered to self-monitor and have confirmed that during their

2014 through 2019 Leavenworth events, similar noise monitoring revealed no violations of the noise limit at any time during similar operating hours.

## 6. <u>Chelan County Prosecution Services Agreement for 2020</u>

The City Council is being asked to approve the 2020 Chelan County Prosecution Service Agreement for prosecution services through the Chelan County Prosecuting Attorney. Through this agreement, the County Prosecuting Attorney will provide prosecution services for misdemeanors and gross misdemeanors filed in District Court for cases arising within the corporate City limits. The fee for the prosecution services will be calculated based on the rate of \$250.00 per case. The total contract amount for 2020 is \$26,500, which is based on the 106 cases that were prosecuted during the 12-month period of September 1, 2018 through August 31, 2019. See the table below for the history of annual contract costs and numbers of cases prosecuted.

## 7. Emergency Management Services Contract for 2020

The City Council is being asked to review and approve the annual contract with the Chelan County Department of Emergency Management for compliance with the Superfund Amendment and Reauthorization Act. The contract covers several items that are financially important to the City of Leavenworth:

- The Emergency Management Department is charged with developing a comprehensive emergency management plan for the City. This plan is critical in securing future FEMA funding by the City, should the City of Leavenworth face a declared emergency incident or disaster.
- The Emergency Management Department would provide emergency and disaster control and coordination, either on site or through the Emergency Operations Center (EOC). The added personnel, professional assistance, and access to equipment would help contain ongoing emergency operation planning costs and costs to the City during an incident. The cost of the contract amount is based on a "per resident" number. The per resident amount is the Emergency Management annual operating budget divided by the number of residents within Chelan County; population numbers on each individual city are derived by the estimates provided on the Office of Financial Management website (<a href="www.ofm.wa.gov">www.ofm.wa.gov</a>).

The amount of the 2020 contract is \$5,977.20, which is calculated at a rate of \$2.93 per estimated City of Leavenworth population of 2,040. The table below reflects contract costs in previous years as a comparison:

The Sheriff's Department based the change in costs in 2015 on a new calculation methodology. The contract amounts are now based on a standard cost per resident throughout small cities in Chelan County. Economic nodes located in Chelan County, such as Peshastin, Monitor, and Manson do not pay an added fee for Emergency Services or Public Safety Services as the small cities do. The Emergency Management Service contract is of benefit to the City; a recent example of the services provided by Emergency Management Services in 2016 was the incident management training exercise focused on "Shelter in Place", traffic management, and emergency response and communication.

### 9. Resolution 18-2019: Grant for Garten Haus Rehabilitation and Expansion

The Chelan-Douglas Housing Authority (CDHA) has requested that all fees associated with the Leavenworth Garten Haus rehabilitation and expansion be waived by the City. The Garten Haus provides housing for low-income residents, specifically 21 apartment units serving residents with an income at or below 30% of the Average Median Income (AMI); 7 units serving 40% AMI; and 3 units serving 50% AMI. While the City cannot waive fees, it does have the ability to consider grants for affordable housing projects, as outlined by Resolution 9-2002.

The CDHA provided the City with preliminary plans for complete renovation of the existing 32 apartments and expansion of 8 new apartments – approximately a three-million-dollar project. Staff used this information to roughly estimate the land use permit, building permit, utility connection, fire permit, and engineering reviews to be \$77,828.

The Housing Committee has reviewed the requirements for providing a grant and the submitted materials and is recommending that the City Council provide a grant not to exceed \$80,000 to be applied to the land use permit, building permit, utility connection, fire permit, and engineering review fees.

## 10. <u>Discussion: Water Treatment Plant – County Zoning Requirements</u>

This time is provided for the Council to review and provide input on a request to amend a section of the Chelan County Code which impacts the ability of the City to modify the Water Treatment Plant. The City Water Treatment Plant is located at 7201 Icicle Road, approximately four miles outside of the City limits, within the County's Icicle Design Review Overlay District (IVDRO). The Water Treatment Plant was constructed in 1971 prior to the IVDRO code adoption in 1983. The IVDRO has very limited permitted and conditional uses, with all other uses being prohibited. Unfortunately, the existing Water Treatment Plant is not listed; therefore, the current facility is considered nonconforming. As a nonconforming structure, it is not permitted to be expanded but may be remodeled, altered or repaired.

The 2018 Water System Plan identified required improvements that may result in expanding the existing facility. In order for the City to consider all design and upgrade considerations to the Water Treatment Plant, the use needs to be either permitted or conditionally permitted in the IVDRO code. The City may request a code amendment to resolve this issue.

## 11. Resolution 20-2019 Chelan County Parcel Number: 241701440450 Roadway Vacation

The City Council is being requested to establish a Public Hearing date and time to consider the vacation of all past roadways within this parcel that have not been vacated prior to this time. The property is Chelan County Parcel Number: 241701440450/Property Identification No: 27395. This property is currently one parcel within the City's Wastewater Treatment Plant Facility. As a requirement of the Rural Development Funding (RD), all properties need to be certified by the City Attorney prior to the City being able to access RD Funds. It was discovered in the research regarding the ownership and certification process, that at one time, a roadway identified as County Road 224 existed on the property. As of this time, no additional records are on file at Chelan County or at the City of Leavenworth that indicate that the roadway has ever been vacated.
