Manager's Report

February 2021

1) Future Events Update

a) May 2021

- i) 5 events in total were originally scheduled for May
- ii) 2 have decided to cancel and ask for refunds
- iii) 2 intend on rescheduling, but are still figuring out new dates that work with their vendors and family
- iv) 1 is still holding out hope they will be able to hold their event as planned. I plan on speaking with them before the end of March to either confirm they will hold to the Phase 2 guidelines for events, or confirm rescheduling

b) June 2021

- i) Accordion Festival has decided to only hold outdoor music this summer

2) New Events/Leads

- a) Two tours with potential clients for events in 2022. Both are strong leads at the moment.

3) Healthy Washington Reopening Plan

- a) We're officially in Phase 2 – 25% Capacity for weddings/funerals (No dancing) and indoor gym activities. Indoor Entertainment and dining can be up to 25% Capacity as well, which would seem to be small concerts or banquets.
- b) There is no news about a Phase 3, so I can't give clients any indication about what it will look like or what goals our region needs to meet to get out of Phase 2.
