GENERAL INFORMATION:

- **Is a Permit Required?** All projects, including new buildings or structures, or changing ANY exterior lighting, or indoor lighting which has the capacity to create light trespass and glare are subject to Leavenworth Municipal Code (LMC) Chapter 14.28. Exemptions include low-wattage holiday decorations and decorative lighting; construction lighting for emergency repairs of a temporary nature; diffused, muted lighting used for yards, driveways, landscaping and/or applied to building faces – zone 3; and, radio, communication and navigation tower lighting. Prohibited lighting includes blinking, flashing, moving, revolving, flickering, changing intensity or color, chase lighting, rope lights, and neon, except lighting which is required for public safety – commercial districts only; any light fixture that may be confused with or construed as a traffic control device; any upward oriented lighting, including sign lighting, except as otherwise provided for in this ordinance, shall only be allowed when it is completely contained by an overhanging architectural element; and, searchlights, beacons and laser source light fixtures.
- **Call or email for assistance.** Please consult with Community Development staff if you have questions or need assistance. If submitting a Design Review Application, it is encouraged that lighting be addressed at the same time. The Design Review Board also welcomes you to consult with them during a regular meeting prior to submitting an application, at no charge. Please call at least 14 days prior to a regular meeting to be put on a meeting agenda.
- **Provide information and applicable drawings with your application which show compliance with the requirements below.** All materials are encouraged to be submitted electronically; however, staff may require hard copies. All materials become the property of the City of Leavenworth.
 1. Plans for exterior lighting which show all design specifications for the proposed lighting, including:

 2. Direction of illumination
 3. Details for shields, baffling, vegetation placement and other methods of light diffusion
 4. Adjacent property uses
 5. Measures to mitigate impacts from light trespass, spillage or over-lighting onto adjacent properties
 6. Elevations of any building face which is proposed to be lighted, with the fixtures and their illumination accurately represented.
