FEES⁴

- System development, service connection, and utility reimbursement (as applicable) charges will be determined by the City, and payment of such charges shall be paid by the Applicant, prior to installation or use of new or upgraded service.
- The applicant acknowledges responsibility to pay monthly utility charges, as billed and according to the adopted rate resolution, with said billing commencing immediately upon completion of the service installation.

REVIEW BEFORE SUBMITTING YOUR APPLICATION

REQUIREMENTS / INFORMATION / INSTRUCTIONS

1. Return the completed application form and required materials to the City for review.
2. For New Service / Connection: Include a scaled⁵ map / site plan, on a maximum 8½" x 11" sheet (separate from and in addition to any site plans included with building plans) showing: the location of the property to be connected to City sewer, all property lines and improvements (existing and proposed), the proposed location of the sewer main connection and service lateral, and service clean out located on private property adjacent to the property line.
 - A. New service taps shall be made on City mains only, and the property to be served must front on, or be contiguous with, a City main. Customers not fronting on a City main will be required to pay for the installation of a new main, including valves and manholes as needed, to City standards and specifications, prior to being hooked up. Costs of engineered plans for main extension, review, and modeling, as necessary, shall be borne by the Applicant. Please contact the City Public Works Department to determine whether a main is available to your property.
 - B. The Applicant shall be responsible for installation and fees. The Applicant shall provide tapping and install all piping and related materials from the main to the point of use. The customer shall be responsible for all costs of materials and installation, as necessary, and charges as included herein. The Applicant shall call for City inspection prior to backfill.
 - C. The work shall be performed by a qualified, licensed (including City Business License) and bonded contractor. ***A Permit to Perform Work in City Right of Way shall be completed by the contractor performing the installation, and approved by the City, before work starts.*** Such permit is in ADDITION to any authorization provided herein, and any building or other necessary permitting. Fees are applicable. The contractor shall provide street cutting, backfill, compaction, ballast, traffic control, and asphalt pavement patching in conformance with the City's requirements and as stated within the Right of Way Permit. The City shall inspect all street work.

- i. The City does *not* normally allow installation between November 1 and March 1 because of adverse weather conditions. Exceptions may be made during periods of abnormally favorable weather.
3. For the purposes of calculating Sewer System Development Charges (SDCs), the City uses a defined factor to measure the estimated wastewater demands of a project called an Equivalent Residential Unit (ERU). SDCs are a one-time fee charged on new development, and certain types of redevelopment or change in use, to help pay for existing and planned infrastructure to serve the development. ERUs are a widely accepted unit of measure when estimating fees. ERUs represent the average wastewater volume generated by a typical single family residence in a particular system. Converting non-residential uses into ERUs measures the impact to the system in comparison to the impact of a single family residence. SDCs are determined as follows:
 - A. **Residential:** For the purposes of calculating the sewer SDC the definition of an ERU is one residential dwelling unit at 175 gallons per day.
 - B. **Multifamily:** Dwelling units in multifamily residential structures are assigned an ERU value of less than one to reflect the fewer number of occupants typically residing in each unit, and an assumed proportionate resulting reduction in wastewater production...
 - C. **Motels, Restaurants, Bars:** ERU's are based on the number of rooms and the number of seats (typical) respectively as defined in the Washington State Department of Ecology *Criteria for Sewage Works Design*.
 - D. **Other Commercial:** For other types of non-residential sewer connections, each equivalent ¾" water meter is considered one ERU using American Water Works Association defined meter capacity to determine the factor for the number of ERU's for each non-residential meter size above ¾". In no case shall less than 1 ERU be assigned to any proposed connection.
 - E. **Change of Occupancy Type:** If, in the sole judgment of the City, a proposed change in occupancy type for an existing structure already connected to the system will substantially increase the amount or character of wastewater flow over that for the previous occupancy, and the SDC for the proposed occupancy would result in a greater SDC than for the previous occupancy... the use of the structure for the proposed occupancy type shall be contingent upon payment to the City of an SDC determined in accordance with this section. The additional SDC charge shall be added to any City permit fees or charges applicable to the proposed occupancy.
 - F. **Special conditions:** For special conditions the City will determine the SDC based on either the ERU table, on estimated wastewater flow, or on a combination of both methods at the City's sole discretion. Flow will be based on either estimated peak day flow or maximum month average day flow at the sole discretion of the City. Special conditions include the following:
 - i. Structures with more than one of the occupancy types listed above.
 - ii. As determined by the City upon review of an applicant's administrative appeal.
 - iii. As determined by the City upon its sole judgment that the specifics of the proposed occupancy and/or its characteristics warrant special determination of the SDC.
4. For all commercial projects, scaled⁶ floor plans and other information as necessary to determine the applicable fee as shown on page 5 shall be submitted.
